

**THE RAIL MALL – CAR-FREE WEEKEND
TERMS & CONDITIONS**



1. General

- a. The Rail Mall Car-Free Weekend (the “Event”) is organised by The Rail Mall Pte. Ltd. (the “Organiser”) and will be held from 27 February 2026 to 19 April 2026 (the “Event Period”) at the open area at Block 1. Activities will take place every Friday, Saturday, and Sunday during the Event Period from 6:00pm to 10:30pm, unless otherwise stated.
- b. Participation in and/or attendance at the Event is subject to these Terms and Conditions (“T&Cs”). By entering the Event premises or participating in any activities, all participants are deemed to have read, understood, and agreed to be bound by these T&Cs and any amendments, additions, or modifications made thereto, which shall be final and binding in all respects.
- c. The Organiser reserves the right to amend, vary, or modify these T&Cs at any time without prior notice. Any updated version of the T&Cs shall supersede all previous versions and shall be effective immediately upon publication or display at the Event venue or official communication channels.
- d. The Organiser reserves the right, at its sole and absolute discretion, to postpone, suspend, cancel, or terminate the Event, or any part thereof, at any time without prior notice and without liability to any party.

2. Event Conduct & Safety

- a. All participants are expected to behave in a respectful, orderly, and safe manner at all times within the Event premises.
- b. The Organiser reserves the right to refuse entry or remove any individual whose behaviour is deemed unsafe, disruptive, inappropriate, or poses a risk to other participants or property.
- c. Participants are responsible for their own personal belongings at all times. The Organiser shall not be liable for any loss, theft, or damage to personal property.

All participants shall bear his/her own costs and expenses incurred in relation to or arising from his/her participation in the Event. The Organiser shall not be liable for any such costs or expenses whatsoever and no reimbursement may be sought from the Organiser.

3. Weather Conditions

- a. This event is subject to weather conditions.
 - a. The Organiser reserves the right to postpone, cancel, or amend or suspend any activity in the event of adverse weather, safety concerns, government regulations or any unforeseen circumstances without prior notice.

4. Alcohol & Prohibited Items

- a. The consumption of alcohol is strictly prohibited within the Event premises.
 - a. Possession of dangerous, illegal, or hazardous items is strictly not allowed within the Event premises.

5. Cleanliness & Waste Disposal

- a. Participants are to maintain cleanliness and dispose of all litter and waste in the designated bins provided.

6. Photography & Videography

- a. Photographs and videos of you may be taken during the event. Such photographs & videos may be stored by the Organiser and the authorised representatives, and may be used on various social media sites, websites, corporate publications and other media. By participating in the event, it signifies your consent to the foregoing.

7. Bouncy Castle Usage

- a. For children aged 3 to 10 years old (as of 2026) only.
- b. Adult supervision is required at all times.
- c. Shoes, sharp objects, food, and drinks are not allowed inside the bouncy castle.
 - a. The Organiser and vendor(s) will not be liable for any injuries resulting from misuse.
- d. Parents and guardians shall assume full responsibility for the safety and conduct of their children.

8. Liability & Disclaimer

- a. Participation in the Event is at the Participant's own risk.
- b. The Organiser shall not be held responsible for any loss, damage, or injury sustained during the event, except where such liability cannot be excluded by law.
- c. In the event of any inconsistencies between these T&Cs and any marketing, promotional or other materials relating to the Event, the Organiser's final decision on such T&Cs shall prevail.
- d. The Organiser reserves the right, in its sole and absolute discretion, to transfer and/or assign all rights and obligations under the Event and the Event T&Cs to another entity pursuant to any restructuring, merger or sale, or for any reason whatsoever, without prior notice and without liability to any party. In such an event, the entity which is assigned all such rights and obligations under the Event and the Event T&Cs shall be responsible for fulfilling all obligations under these Event T&Cs (whether arising on or prior to the date on which such obligations are transferred and/or assigned) as if it had been named in the Event T&Cs in place of the Organiser.

9. Indemnity

- a. Participants agree to indemnify and hold harmless the Organiser, its employees, vendors, and contractors from any claims, liabilities, damages or expenses arising from their participation in the Event, except where caused by the Organiser's negligence.

10. Governing Law

- a. These T&Cs shall be governed by and construed in accordance with the laws of Singapore, and all parties agree to submit to the exclusive jurisdiction of the courts of Singapore.
